2022 GHG-Free Energy Allocation Frequently Asked Questions

Questions	SCE Response
1. Are all Load Serving Entities (LSE) eligible to participate?	Yes, all LSEs whose customers pay Cost Responsibility Surcharges (CRS) are eligible to participate.
2. Are there costs associated with an LSE choosing to take an allocation?	No additional cost is required. Customers in SCE's service area who pay Cost Responsibility Surcharges (CRS) pay their share of the full net costs of the GHG-Free Energy resources in SCE's CRS portfolio on a vintaged basis and may receive their share of the GHG-Free attributes of those resources on a vintaged basis under the Proposal.
3. Are Eligible LSEs allowed to enroll or change their allocations intra-year?	No, enrollment and elections can only be made during the annual enrollment and election window. The LSE election cannot change once it is made.
4. When must enrollment and elections be made to participate in the 2022 GHG-Free Energy Allocation?	For Community Choice Aggregators (CCAs) and Electronic Service Providers (ESPs) in SCE's service area whose customers pay CRS, the 30-day enrollment and election window will begin on November 1, 2021 and end on November 30, 2021.
5. When does the allocation period begin for 2022?	The allocations for 2022 will begin on January 1, 2022.
6. Will allocations be made retroactively?	No, GHG Free Energy allocations will not be retroactive.
7. Why are the Advice Letter and Term Sheet framed as an interim solution?	This interim solution was put in place until the Commission issues a final decision in Working Group 3 of Phase 2 of the PCIA Order Instituting Ratemaking, which was issued on May 24, 2021 (D.21-05-030). However, the Decision did not address allocations of GHG-Free attributes. Instead, it allowed the IOUs, at their sole discretion, to continue to allocate GHG-Free attributes as provided under Advice Letter 4194-E through December 31, 2023. SCE is allocating GHG-Free attributes for 2022, as it believes this is fair and equitable to LSEs whose customers are paying their share of the CRS.
8. How long will SCE continue to allocate GHG-Free attributes?	On May 24, 2021, the Commission issued D.21-05-030 in Rulemaking (R.)17-06-026, the Power Charge Indifference Adjustment Order Instituting Rulemaking (the "PCIA OIR"), authorizing SCE to continue this approach until December 31,

	2023. SCE is offering its Standard Offer GHG-Free Allocation for Term Year 2022. SCE may, in its sole discretion, offer allocations for calendar year 2023 in 2022.
